STAY COVERED: RENEW YOUR MEDICAID OR KCHIP EVERY YEAR



CHILD RENEWALS
RESTARTING JULY 2025

If you or someone in your household has Medicaid or KCHIP (Kentucky Children's Health Insurance Program), you must renew your coverage each year to keep your benefits.

MEDICAID IS PROVIDED BY THESE INSURERS IN KENTUCKY

1. WATCH FOR YOUR RENEWAL NOTICE

You'll get a renewal notice in the mail from the Cabinet for Health and Family Services about 30–45 days before your renewal date.

The notice will include instructions and a deadline to submit required information.

2. KNOW YOUR RENEWAL MONTH

Check your renewal month by:

- Logging into the kynect portal at kynect.ky.gov
- Calling 855-4kynect (855-459-6328)
- Finding a kynector on kynect.ky.gov
- · Asking your provider to check KYHealthNet

3. UPDATE YOUR CONTACT INFO

Make sure Medicaid has your current:

- Mailing address
- · Phone number
- · Email address

This way, they can contact you without delay.

Update your info through:

- The kynect portal at kynect.ky.gov
- The kynect hotline at 855-4kynect (855-459-6328)

4. CHECK YOUR MAIL

- When it's time to renew, you'll get a letter telling you if you need to fill out a form or send information.
- If requested, send the info right away to avoid losing coverage.
- Keep copies of everything you submit and note the submission date.

NOTICES YOU MIGHT RECEIVE



Renewal Notice - Tells you what to submit to stay covered.

Notice of Eligibility - Confirms who in your household qualifies and when coverage starts/ends.

Request for Information - Asks for documents to complete your application or renewal. Act fast or your coverage may end.

INCOME LIMITS ARE HIGHER FOR KIDS

Household Size	Limit for Adults	Limit for Kids under 19
3	36,780	58,104

When in doubt, fill it out! The state will decide if you qualify. Once approved, kids are covered for 12 months.

WHAT IF YOU LOSE COVERAGE?

Here are your options:

- Reapply for Medicaid or KCHIP on kynect. Previous info is saved to make it easier.
- Enroll in a kynect Marketplace plan. Many qualify for lowor no-cost options.
- Enroll in Employer-Sponsored Insurance (if available).
- Sign up for Medicare if you're turning 65 within the next 3 months.

Losing Medicaid counts as a Qualifying Life Event (QLE) you can enroll in a new plan outside the normal Open Enrollment Period.

Parking- Do not park cars on the grass or sidewalks. Sidewalks are for walking or bike riding.

Please bag all trash and tie it closed to keep the smell down and flies out when throwing it in the dumpsters. Please place all trash in the dumpsters and not leave setting beside or on the dumpster.

Please remember that car washing, pools, or hooking hoses or sprinklers with water from your apt is not allowed, per your lease.

As in accordance with your lease, residents have 14 days per year of visitation. This is a total of all visitors, each day. If you would like to add someone to your lease, contact our office. Violators will be given a lease violation notice. Residents who allow guests to stay past the 14 day limit are subject to lease termination.



Key Dates to Know:

- First day of school/after school programming: Thursday, August 7, 2025
- Bus transportation from Henderson County Schools begins: Monday, August 18, 2025

NOTE: Student's attending school outside of South Heights, Jefferson, and South Middle School will need parent/guardian to drop student off afterschool to the CAT Center until Monday, August 18, 2025.

Last day to register: Wednesday, August 13, 2025

Due to limited transportation availability from the Henderson County Bus Garage, the Housing Authority CAT Center vans will be transporting students from:

- South Heights Elementary
- Jefferson Elementary
- South Middle School



We will provide transportation home between 4:45 PM and 5:00 PM for students who live in the Housing Authority developments. If your child is not riding the van home, please pick them up no later than 5:15 PM.

Eligibility:

Students must be in 1st - 12th grade and at least 6 years old to participate.

Important Reminders:

- Parents/guardians must complete a new enrollment and transportation form for the 2025–2026 school year.
- The CAT Center follows the Henderson County Schools calendar. If schools are closed due to weather, holidays, or early dismissal, the CAT Center will also be closed.
- Any additional schedule changes will be communicated via phone call or text message.



- All household members age 18 years and older must be present to sign.
- You must have Social Security Cards for all members of the household.
- Birth Certificates must be provided for all household members and a photo ID for all adults.
- If anyone is pregnant a statement must be presented as to due date.
- For Public Housing you must have proof of income. There may also be other documents that may be needed. You can come to the office and pick up a list that show what other documents will be needed.

Re-Exams:
