

IMPLEMENTATION OF THE NEW FLAT RENT PROVISION

(Affects Only Those Residents Who Are Currently Paying the Flat Rent Option)

The Housing Authority of Henderson hereby amends its flat rents to comply with the statutory changes contained within, Public Law 113-76, of the Fiscal Year 2014 Appropriation Act.

The 2014 Appropriations Act requires the Housing Authority of Henderson to establish flat rents at no less than 80% of the applicable Fair Market Rent (FMR) as established by The Department of Housing and Urban Development (HUD) for Henderson County.

Flat Rents are based on FY 2023 Small Area Fair Market Rents for Henderson County, KY.



The Volunteer and Information Center and Green River Asset Building Coalition will again provide FREE Tax Assistance (Volunteer Income Tax Assistance (VITA) program at the Housing Authority. Look for our yellow and green doors to enter.

- · The Henderson County VITA site is located at the Housing Authority of Henderson, 111 S. Adams St.
- Site hours are Noon to 7 p.m. Monday and Tuesday and Saturdays from 9 a.m. to Noon.
- We have a new Client Portal that will allow patrons to check on returns.

Intake documents are available in the Housing Authority vestibule during HA's regular business hours.

In past years, volunteers in the VITA program have been able to help more than 1,700 people in Henderson County get their taxes prepared for free and deposit over \$2.5 million in local banks from returns.

Healthy at Home Eviction Relief Fund:

The Housing Authority of Henderson will no longer be accepting or processing applications for the Healthy at Home Eviction Relief Program. Gov. Beshear stated that rent and utility assistance applications through the Healthy at Home Eviction Relief portal will no longer be reviewed or accepted after Friday, January 20, 2023 at 5:00 p.m.

If you applied for the Healthy at Home Eviction Relief Fund and have not signed your settlement agreement before the January 20, 2023 deadline, you need to contact Team Kentucky at (833) 597-3687 to check the status of your application.

Please remember you are responsible for the payment of your rent and charges by the date outlined in your signed lease agreement.

Lashunda has over 20 years Public Housing experience. She is from Tennessee. She is the new Manager for Lawndale, Dixon, Madison, and the 3 houses.

Rent Collection: Friendly reminder that your rent is due on the 1st day of each month. Rent is considered **late** at 8:00 a.m. on the 11th day of the month. Please consider using your tax refund or stimulus to get caught up on your rent and start paying on-time. Payment history is always asked and answered on landlord verifications, applying for a loan, and applying for a mortgage. When paying your rent, please fill out checks and money orders completely. Please make them payable to the Housing Authority of Henderson. Make sure your name is legible and your address is on the check or money order to ensure your money is being properly applied.

Parking: This is a reminder all parking is first come, first served. Please be considerate of neighbors and park second cars and guest's cars away from the apartments. Please do not park in yellow curbed areas. The yellow areas are marked for fire and emergency services only and allows emergency vehicles to have easy access to apartments. The life they are saving might just be yours or that of a family member.

Be Consideration of Neighbors: We have had complaints about some neighbors slamming doors and running up and downstairs all hours of the night. Please be considerate of others.

Stray Cats and other Animals: Please do not feed and shelter stray animals. This is causing serious problems. We receive daily complaints about stray animals running into resident's apartments and animal waste on Housing Authority's property. Stray animals may carry disease. This could be a health and safety risk to you and pets who are living in the units.

Pets and Service Animals: The policy states when your animal is outdoors, it should be on a leash. Several residents are not following that policy. We have received complaints concerning non-leashed animals running up on leashed animals and causing problems. Please leash your pet while outdoors and dispose of your pet's waste immediately.

Smoking Reminder: There is **no smoking** of any kind or vaping allowed inside the apartments. You must be 25 feet from any door or window.

Christmas Decorations: Please remove all outdoor holiday decoration, including pumpkins, snow on windows, aetc.

5 Things to Do Every Day to Keep Your

Cardiothoracic surgeon, Marc Gillinov, MD, recommends five key things you need to do every day to help your heart work most efficiently. Incorporate these habits into your lifestyle and your heart health will be the best it can be for you.

- 1. Eat healthy fats, NOT trans fats.
- Practice good dental hygiene, especially flossing your teeth daily.
- 3. Get enough sleep.
- 4. Don't sit for too long at one time.
- Avoid secondhand smoke.





Waffle Heart Sandwiches (serves 2)


INGREDIENTS

- 4 slices sandwich bread
- 2 tablespoons whipped cream cheese
- honey, to taste
- 6-8 fresh raspberries

PREPARATION

- 1. Preheat waffle iron.
- 2. Using a large heart shaped cookie cutter, cut the bread into hearts.
- 3. Spread half the cream cheese on 1 heart and drizzle with honey to taste. Flatten the raspberries by opening them up with your fingers. Place 3-4 raspberries on top of the cream cheese and top with another plain piece of heart bread. Place the sandwich in the waffle iron for 3-4 minutes or until golden brown.

- All household members age 18 years and older must be present to sign.
- You must have Social Security Cards for all members of the household.
- Birth Certificates must be provided for all household members and a photo ID for all adults.
- If anyone is pregnant a statement must be presented as to due date.
- For Public Housing you must have proof of income. There
 may also be other documents that may be
 needed. You can come to the office and pick up a list that
 show what other documents will be needed.
