## IMPLEMENTATION OF THE NEW FLAT RENT PROVISION

(Affects Only Those Residents Who Are Currently Paying the Flat Rent Option)

The Housing Authority of Henderson hereby amends its flat rents to comply with the statutory changes contained within Public Law 113-76, of the Fiscal Year 2014 Appropriation Act.

The 2014 Appropriations Act requires the Housing Authority of Henderson to establish flat rents at no less than 80% of the applicable Fair Market Rent (FMR) as established by The Department of Housing and Urban Development (HUD) for Henderson County.

Flat Rents are based on FY 2024 Small Area Fair Market Rents for Henderson County, KY 42420.

The following are the new flat rents for the Housing Authority of Henderson: The new flat rental amount will apply to all current program participants at the next annual recertification option.

## **Dwelling Unit Inspections:**

In the months of September, October and November, the Housing Authority staff performed semi-annual inspections at Lawndale, Eighth Street, Madison and Dixon Developments. During the inspection, we found several dwelling units that failed inspection due to **housekeeping and maintenance issues.** 

The resident is expected to keep the apartment in a clean, safe and sanitary manner. Residents should clean up spills, keep all floors clean and clear of clothes and debris, empty trash, and clean all surfaces, including appliances and counter tops on a regular basis. In addition, it is imperative that you call (270) 827-1294 immediately for all maintenance repairs.

#### **PUMPKINS**

#### FALL LEAF SEASON

Families are responsible for raking and bagging their own leaves. We will remove the bagged leaves for you. If maintenance staff has to rake your leaves, you will be charged a fee. Bags are available at the office, and we will loan you a rake if needed.

#### CHRISTMAS DECORATIONS

Please use clips when installing outdoor lights. Do not use nails or screws to attach decorations to the apartment buildings. Do not attach any decorations to the rails at 840 N Adams.

### **Freezing Pipes**

When temperatures are below freezing, please leave cabinets open and faucets dripping to prevent pipes from freezing and bursting.

#### Water Shut Off

Please take a moment to find the water shut off in your unit. If you have questions, feel free to ask maintenance where yours is located. In the two-story units they are located in the utility room and in the smaller units they are located in the large closet and the kitchen closet. Water shut offs are also located at each individual house such as the toilet and sinks.

#### FIRE AND SAFETY TIPS

## **Apartment Safety**

- Never leave electrical appliances, modems, and cell phones on the floor, on cloth furniture or near a water source.
- Protect your appliances and your home by using surge protectors.
- Do not overload circuits or extension cords.
- Check electrical cords for appliances. Cords that are frayed or cracked are potential fire hazards.
   Unplug the cord immediately and replace.
- Do not run cords underneath rugs or between rooms.
- Never place portable space heaters near flammable materials, such as drapery.
- Turn off space heaters when leaving the room or going to bed.
- Do not smoke in bed or leave burning cigarettes unattended.
- Keep lighters and matches out of reach of children.
- Do not leave candles, incense, or wax burners unattended. Keep them away from drapes, curtains or other flammable materials.
- Do not store flammable materials, such as gasoline cans or a propane tanks, in your apartment.

## Kitchen Safety

- Never leave food unattended on a stove.
- Keep potholders and towels away from the cooking area.
- Avoid wearing loose-fitting sleeves when cooking.

## **Laundry Room Safety**

- If possible, have your dryer installed and serviced by a professional.
- Avoid using a dryer without a lint filter that is secure on the dryer vent to the outside. If you see dust or debris in your utility room your vent is not secure.
- Clean the lint filter before or after each load of laundry and remove lint that has collected around the drum of your dryer.
- Use the proper plug and outlet for the dryer, and ensure it is connected correctly.
- Always turn the dryer off when leaving home or going to bed.

#### HENDERSON COUNTY SCHOOLS INSTALLS CENTEGIX **CRISIS ALERT SYSTEM**

Henderson County Schools has recently installed the Centegix Crisis Alert System in every school building in the district. The system includes wearable badges for staff with an emergency button. Once the button is pressed, audio and visual notifications

are sent facility-wide using colored strobe lights, desktop alerts, and building intercoms. This will allow the entire building to go on lockdown instantly. Strobe lights are installed in classrooms, hallways, gymnasiums, cafeterias, and around the school property.

"Our top priority is the safety of our students and staff. By implementing the Centegix Crisis Response Solution, we are adding another layer of safety and taking a proactive step to ensure that we are prepared for any situation that may arise," notes Dr. Bob Lawson, Superintendent of Henderson County Schools.
